CITY OF ELBERTON REGULAR MEETING OF THE MAYOR AND COUNCIL

Monday, December 4, 2023 – 5:30 p.m.

Pursuant to due call and notice thereof the meeting of the Mayor and Council convened at 5:30 p. m. on Monday, December 4, 2023 in the Council Chamber of the Municipal Building, 203 Elbert Street with Mayor Graves presiding.

Present were: Council Members Butler, Burton, Colquitt, Prince and Parham; City Manager Dunn, City Clerk Churney and City Attorney Jenkins.

Mayor Graves called the meeting to order and led the assembly in the Pledge of Allegiance. City Attorney Jenkins led the assembly in prayer.

Council Member Butler motioned to approve the minutes of the October 2 meeting, seconded by Council Member Burton, and the motion passed unanimously (Butler, Burton, Colquitt, Prince, Parham).

There were no speakers from the floor scheduled to speak. There were no Ordinances or Resolutions to consider at the meeting.

Council Member Parham motioned to adopt the Consent Agenda, seconded by Council Member Colquitt and the motion passed unanimously (Butler, Burton, Colquitt, Prince, Parham).

- 3. Accepted the November 7, 2023 Municipal General Election results for Council Member Ward 3, as follows: 28 votes for Troy Colquitt (incumbent) and 15 votes for Kendra Jones with a total of 43 votes received during the election.

City Manager Dunn presented the following reports:

- 1. Financial Report ending October 31, 2023.
- 2. Monthly departmental report, as follows:

CITY CLERK:

The department submitted the Annual Comprehensive Financial Report for the fiscal year ending June 30, 2023 to the Tax and Expenditure Center at the Carl Vinson Institute of Government as required by Georgia Law.

The department submitted the Special Purpose Local Option Sales Tax (SPLOST) projects report for the year ending June 30, 2023. O.C.G.A. 48-8-122 requires this report to be published in the newspaper no later than December 31 of each year.

The department submitted alcoholic beverage license renewals for 2023 to council this month.

The Sister City program hosted delegates from Mure-cho, Japan for the 40th anniversary.

The Municipal General Election was held November 7 to elect a Council Member from Ward 3. Incumbent Troy Colquitt was reelected with 28 votes to Kendra Jones' 15 votes. A total of 43 votes were cast during the election, which was an 8% of voter turnout.

The annual illegal immigration reporting requirements for 2023 was submitted to the Georgia Department of Audits & Accounts. This is an extensive reporting required by the State of Georgia every year.

The department submitted the EEO-4 data collection report for the fiscal year ending June 30, 2023 to the U.S. Equal Employment Opportunity Commission.

FIRE DEPARTMENT:

The Fire Department responded to 51 Alarm Calls for the month of November, 2023. These calls consisted of 27 Medical Emergencies, 1 Building Fire, 7 Vehicle Accidents, 9 Aircraft Standbys, 1 Camper Fire, 1 Wild land Fire, 1 Grass Fire, 1 Flammable Liquid Spill, and 3 False Alarms. The Fire Department conducted 365 hours of in-house training.

BUILDING INSPECTIONS:

The Building Inspection Department issued 6 permits from October 26th to November 27th which included 5 Building Permits and 1 Sign Permit.

During this same period there were 2 Electrical Inspections, 1 Plumbing Inspections, 2 Demo Inspection, 7 Building Inspection, 4 Roofing Inspections, 1 Driveway Inspection, and 1 Mechanical Inspection.

POLICE DEPARTMENT:

The Elberton Police Department released their monthly activity for the month of October 2023. The department recorded:

- 967 Calls for Service
- 330 Vehicle Traffic Stops
- 95 Incident Reports were filed
- 212 City Court cases made
- 27 Traffic accidents were investigated

- 48 People were arrested for various charges
- 5 Person was arrested for Driving under the Influence
- 188 Department Training Hours

WATER & SEWER:

The crew abandoned an old 2 inch galvanized main and ran a new HDPE line to feed two meters on Lake Forest Circle. The crews raised valves ahead of the street pavers. The crews installed a new water tap and meter at 1609 Melody Lane. The crews continued surveying material type on city and customer side of water service lines as mandated by the Georgia EPD to meet new Lead and Copper Rule Revisions.

ELECTRIC:

During the month of November the Electric Department installed a new pole and connected a new underground service for the MedNow urgent care center on Elbert St. The department installed 2 underground services for homes on Lithia Springs Road and Railroad Street. The department finished building the overhead line for the second new poultry farm on Limo Road.

GAS:

The Natural Gas Department activated service to the first poultry farm on Limo Road, and completed the installation to the second farm. The new main line and regular station on Mineral Springs Road was pressurized and activated. The Department is continuing to perform the annual leak survey required by federal regulations.

PUBLIC WORKS:

Along with monthly routine maintenance, the Street Department began to prep the area for the concrete pad at the new training facility for the Fire Department on Calhoun Falls Hwy.

ELBERT THEATRE & ELBERTON ARTS CENTER:

There were 27 events at the Elbert Theatre & Arts Center from Nov. 1-21 including Encore Productions' A Gift to Remember rehearsals and Pippin auditions; Killers of the Flower Moon & Trolls Band Together movies; ETF's The Lion, the Witch and the Wardrobe open reading, and a Christmas Movie Field Trip.

Approximately 527 patrons visited the Elbert Theatre & Elberton Arts Center during this period.

MAIN STREET ELBERTON:

Main Street held its annual Granite City Fall Festival on Saturday, November 4th from 9 a.m. to 3 p.m. We had the band Big Teach to perform from 11 a.m. to 2 p.m. We had over 100+ vendors signed up for this year's event.

12 Days of Christmas Cash kicked off on Friday, November 10 and was extended an additional week due to us having to postpone our annual Candle Light Shop Night that was to be held on Tuesday, November 21 and was moved to the following Tuesday, November 28 due to rain. Over 20 local craft vendors registered to participate with this annual event with an L3 Baton performance, pictures with Santa, carolers etc.

ELBERT HOTEL:

November's occupancy will complete the month around 59%, continuing the high occupancy this fall. Thanksgiving night had 96% occupancy, and several other nights in November also had occupancy above 90%. UGA home footballs game weekends have typically filled to 100% occupancy this fall including Saturday, November 11. We expect occupancy to drop in December and January for the winter season as has been seen in prior years.
