Regulated Mailbox Placement:

In accordance with Section 32-13 of the Code of the City of Elberton, the City Manager has the authority to authorize the placement of mailboxes within the public right-of-way of the City.

Residents are responsible for any damages to any utility line and will be charged accordingly for all repairs and replacements. If at any time something is damaged stop immediately and call 706-213-3116.

- Position your mailbox 41" to 45" from the road surface to the bottom of the mailbox or point of mail entry.
- Place your mailbox 6" to 8" back from the curb. If you do not have a raised curb, contact your local postmaster for guidance.
- Put your house or apartment number on the mailbox.
- If your mailbox is on a different street from your house or apartment, put your full street address on the box.
- Residents are responsible for calling Georgia 811 (dig permit) before disturbing the ground.
- Contact the United States Postal Service for construction and size requirements.
