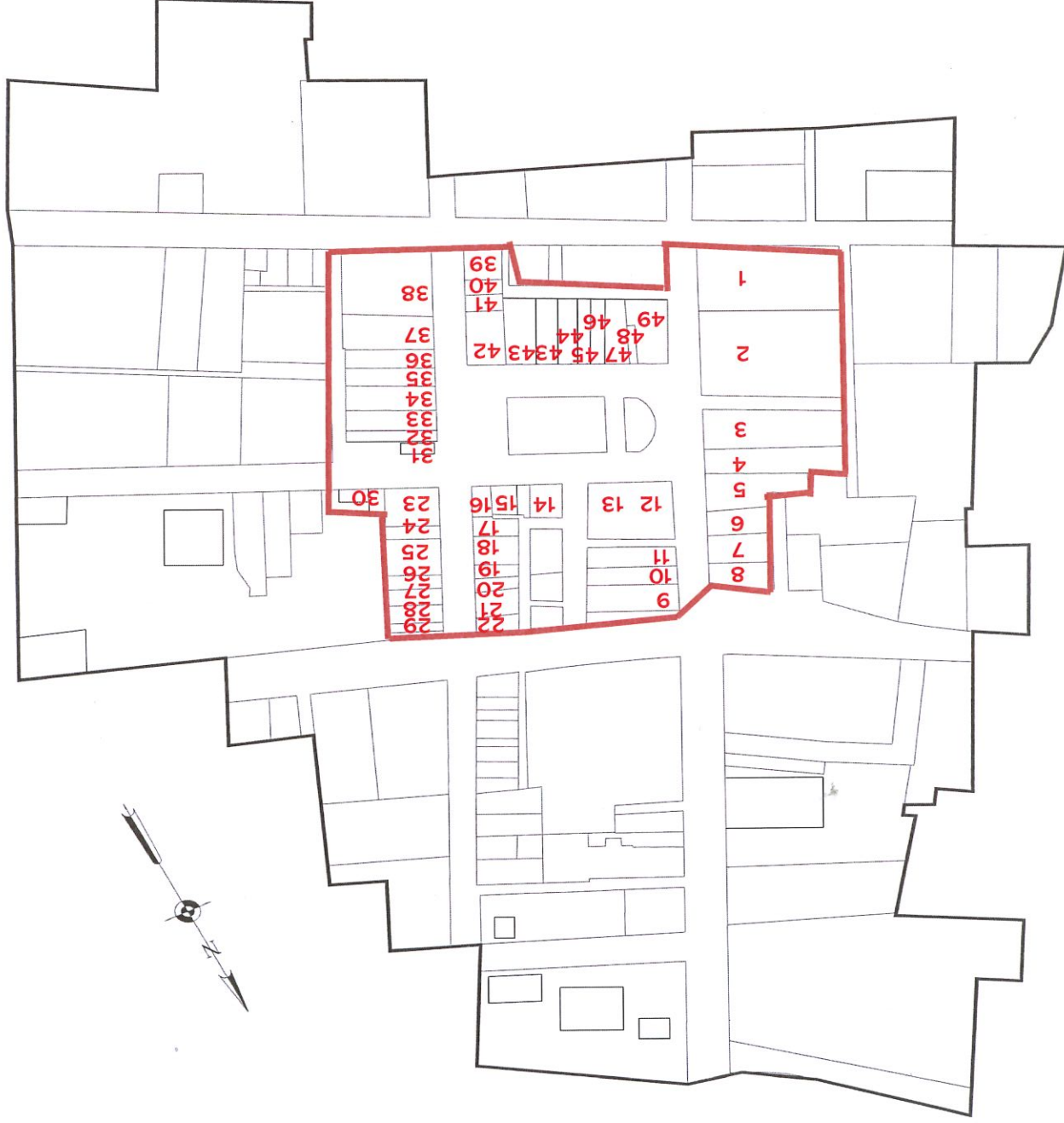


CITY OF ELBERTON
